

5-Year Limited Warranty

DAY ONE AUTO INSTALLATION WARRANTY

DAY ONE AUTO PROVIDES A 5-YEAR LIMITED WARRANTY ON INSTALLATION SERVICES, EFFECTIVE FROM THE DATE LISTED ON THE INSTALLATION INVOICE.

IF A DEFECT IN INSTALLATION OCCURS DURING THE WARRANTY PERIOD AND IMPACTS THE PERFORMANCE OF THE COMPONENT, DAY ONE AUTO WILL, AT ITS DISCRETION:

- REPAIR THE DEFECT,
- REINSTALL THE COMPONENT, OR
- ISSUE A REFUND FOR THE INSTALLATION COST.

INSTALLATION WARRANTY EXCLUSIONS

THE WARRANTY DOES NOT COVER ISSUES OR DAMAGE CAUSED BY:

- MISUSE OF THE PRODUCT OR IMPROPER SETUP
- LACK OF MAINTENANCE OR FAILURE TO FOLLOW CARE INSTRUCTIONS
- ABUSE OR EXCESSIVE FORCE
- ACTS OF NATURE (E.G., FLOODS, LIGHTNING, ETC.)
- FAILURE OF OTHER COMPONENTS THAT RESULT IN DAMAGE TO THE INSTALLATION
- ACCIDENTS
- NORMAL WEAR AND TEAR OF REPLACEABLE PARTS

THIS WARRANTY IS LIMITED TO DEFECTS IN THE INSTALLATION WORKMANSHIP AND DOES NOT COVER DAMAGE OR ISSUES CAUSED BY FACTORS BEYOND DAY ONE AUTO'S CONTROL.

Warranty

DAY ONE AUTO PRODUCT WARRANTY

DAY ONE AUTO PROVIDES A 1-YEAR LIMITED WARRANTY ON CONSUMER PRODUCTS, COVERING DEFECTS IN MATERIALS AND WORKMANSHIP FROM THE ORIGINAL DATE OF PURCHASE.

FOR ELECTRONIC PRODUCTS, IF A DEFECT IS IDENTIFIED BY DAY ONE AUTO, THE PRODUCT MUST BE DIAGNOSED, UNINSTALLED, AND SENT OUT FOR SERVICE.

WARRANTY EXCLUSIONS

THE WARRANTY DOES NOT COVER DAMAGE, FAILURE, OR ISSUES CAUSED BY:

- ACCIDENTS
- MISUSE OR IMPROPER HANDLING
- UNAUTHORIZED MODIFICATIONS OR ALTERATIONS
- ACTS OF NATURE (E.G., FLOODS, LIGHTNING, ETC.)
- UNREASONABLE OR IMPROPER USE OUTSIDE THE PRODUCT'S INTENDED PURPOSE
- LACK OF PROPER MAINTENANCE OR FAILURE TO FOLLOW CARE INSTRUCTIONS
- ABUSE OR EXCESSIVE FORCE
- NORMAL WEAR AND TEAR ON REPLACEABLE PARTS
